#### World Heritage Update

Welcome to the third edition of the Rainforest Aboriginal News (RAN).

The 2017 'People Country Culture' Calendar was very deadly and a big hit! Thanks to all who contributed artwork, photos, stories and content.

It's so exciting to see the Authority and Terrain collaborating on the Rainforest Aboriginal Grants to make the process of applying easier. Round 1 Expressions of Interest (EOI) have closed, but Round 2 EOIs will be advertised in August and we encourage you to apply. Successful applicants from Round 1 will be announced by the end of April.

The planning team at the Authority spoke with Prescribed Bodies Corporates (PBCs) at the North Queensland Land Council governance training in February about the Wet Tropics Management Plan review process. Aboriginal Partnerships staff will be in touch with your PBCs to yarn about this further.

The Scientific Advisory Committee (SAC) and Community Consultative

Committee (CCC) met in February. The SAC recommended the Authority prepare a framework to facilitate better engagement between researchers and Rainforest Aboriginal people. The CCC recommended the Authorities various engagement

strategy actions make a connection with aspirations in the Wet Tropics Regional Agreement and the Which Way our Cultural Survival report.

The Board met on 7 March 2017. Directors considered the Wet Tropics Management Plan review process and intentions to improve the recognition of Aboriginal Tradition. Directors were also updated on the Yellow Crazy Ant Eradication Project (YCAEP) and Student Research Grants.

The Authority has recently signed a three year Partnership Agreement with the Departments of Environment and Heritage Protection (EHP) and National Parks, Sports and Racing (NPSR). The agreement includes performance measures to enhance Rainforest Aboriginal engagement through planning, operational activities and regard for cultural practices in National Parks. Some Queensland Parks and Wildlife Service (QPWS) staff profiles are included in this edition and we encourage you to get in touch with your local Rangers.

The Authority is also happy to announce a recent increase in Indigenous employment positions in YCAEP, Business Management and Aboriginal Partnerships (See the back page for more information).

#### NRM Update

This Terrain update sees the retirement of Mike Berwick from his position as Chair of Terrain NRM and the Queensland Regional Groups collective. Dr Keith Noble will Chair Terrain until a new Chair is appointed at the Annual General Meeting in November.

The Wet Tropics Major Integrated Project (MIP) has welcomed Alf Joyce and Clarence Kinjun to the Project Panel. The MIP aims to reduce nutrient, sediment and pesticide loads into waterways in the region. Alf is a Ma:Mu man and is providing advice on Traditional Owner interests in the Lower Johnstone Catchment. Clarence is a Gulnay man providing advice on Traditional Owner interests in the Tully Catchment.

Rainforest Aboriginal Grants provide excellent opportunities for support to your group and I encourage you to submit an application in further rounds if you didn't apply in Round One.

and there is a village site now flooded.

Today, Gimuy people are interested in ecologically sustainable use and management of Minjilji to protect culturally sensitive areas.

Gimuy Rangers and Abriculture conducted a baseline survey on foot in areas identified by Elders. The purpose of this survey was to identify important biocultural hotspots and areas suitable for tracks and future recreational activities. The baseline survey recorded 123 species of plants, 76 animal tracks, scats and other applied for a small grant with the Authority which helped to fund Gimuy rangers and Elders to get out onto country. Gimuy also worked with Cairns Regional Council to secure road and boat access for the baseline survey.

These findings show the potential for future development of walking tracks, cultural tours, and guided cultural camping trips. Gimuy Traditional Owners believe that this would not only be possible, but would add value to Cairns and the Wet Tropics region.

## The fight against Yellow (razy Ants

Yellow crazy ants are listed among the world's 100 worst invaders. The name 'crazy ant' comes from their frantic movements, especially when they are disturbed. The ants were first found within the World Heritage Area and Little Mulgrave National Park in 2012.

In 2013 the Wet Tropics Management Authority was funded \$2M over five years to eradicate a large yellow crazy ant infestation in the Edmonton area. The program is also working to eradicate a smaller infestation at Russett Park near Kuranda.

In late 2016 the Authority received commitments of \$7.5M from the Australian Government and \$3M from the Queensland Government to continue the eradication program until 2019 as part of a ten year eradication program. With access to the additional funding the Authority's Yellow Crazy Ant Eradication Program (YCAEP) team are now in a position to deploy their own operations and monitoring field teams.

To help deliver surveillance and treatment on time the YCAEP team have entered into a Memorandum of Understanding with the Gimuy Walubara Yidinji Abriculture Rangers. This work is to assist existing field crews in the Edmonton area over a period of four weeks, with potential additional fee for opportunities in the future. Similar opportunities are also being explored in Kuranda for the Djabugay Bulmba Rangers once they are established.

Yellow crazy ants have invaded around 900 hectares of land in the region, including over 200 hectares of rainforest inside and outside the World Heritage Area.

We have a strong interest in sharing skills and knowledge related to invasive ant management with local Rainforest Aboriginal groups. We are keen to work together and support Indigenous groups with opportunities to respond to threats like yellow

More than 30 Indigenous women from the Wet Tropics came together over three days in March to attend the Jalbu Jalbu (women) land and sea management workshop hosted Jabalbina Yalanji Aboriginal Corporation.

The opening ceremony was held at a Women's place sacred healing waters. Yalanji women shared their experiences about trying to protect this special place.

International Women's Day was celebrated on day two of the workshop. This year's theme "Be Bold for Change" tied in nicely with the workshop

program. Important questions were workshopped by the women including how to encourage greater participation by women in caring for country, and our rights and responsibilities in the workplace.

The workshop has signalled the

beginning of a more collaborative network of Indigenous women in the Wet Tropics. An agreed outcome was to produce a short video to promote the contribution and value Indigenous women bring to the workplace. #### Wet Tropics Management Plan Review

The Authority is seeking Rainforest Aboriginal people's views on how the Wet Tropics Management Plan 1998 can better recognise Rainforest Aboriginal Tradition and the contribution of traditional management practices in the Wet Tropics World Heritage Area.

The Authority's Aboriginal Partnerships team will support the plan review team to contact Registered Native Title Body Corporates (RNTBCs) and PBCs to the review periods. Staff will also discuss the ways that the Authority can best support these meetings to take place. A contractor will assist Rainforest Aboriginal people make a formal submission.

**Stage 1:** Initial feedback is sought from May to June 2017.

Stage 2: A draft of proposed changes to the Plan will be released for public comment in early 2018.

### Djabugay Bulmba Rangers

Over the past few months the Djabugay Aboriginal Corporation's have been developing the Bulmba Ranger program. To have rangers working on country has long been an aspiration within the Kuranda Indigenous Community.

This aspiration is now becoming reality after successfully attaining a grant through the Queensland Department of Environment and Protection Heritage Indigenous Land and Sea Ranger Program and a work-for-the-dole arrangement with Rise Ventures.

To prepare for the Bulmba Ranger program the Buda:dji Aboriginal Corporation has been holding workshops with stakeholders and potential partners and is currently recruiting rangers.

It is envisaged that the rangers will undertake work in managing cultural and natural resources as well as flora and fauna surveys to gather a greater understanding of biodiversity and vegetation values.

Djabugay Aboriginal Corporation's are entering into a Memorandum of Understanding with the Mona Mona Aboriginal Corporation which will allow the Bulmba Rangers to work in the Mona Mona Reserve. In addition to their work at Mona Mona, the Bulmba Rangers will also support the Yellow Crazy Ant Eradication Program to control the Yellow Crazy Ant infestation in Russet Park near Kuranda.


