

# Wet Tropics Management Plan 1998 Information Sheet No. 1

## **General Information**

## Do I Need to Apply for a Wet Tropics Permit?

The Wet Tropics Management Plan 1998 commenced operation on 1 September 1998.

The purpose of the Plan is to help protect the Wet Tropics World Heritage Area (WHA).

The Plan regulates activities that have a potential to adversely impact on World Heritage values or the enjoyment of those values.

## This Guide will help you to:

- determine whether you need to apply for a Wet Tropics Permit, and if so,
- · how to make an application, and
- where to get further information

## Plan Applies Inside the Wet Tropics World Heritage Area

- You do not need a Wet Tropics Permit for activities conducted outside of the WHA.
- Maps of the World Heritage boundary are available for viewing at the Authority, the Department of Natural
- Resources and Mines (DNRM), the Queensland Parks and Wildlife Service (QPWS) and local government offices throughout the region or you can phone the contact numbers given below.

## How do I know if my activities require a Wet Tropics Permit?

If you intend to undertake one or more of these activities then you may need to apply for a permit.

## Disturbance to native plants, waterways and earth:

- clearing of native vegetation
- disturbance to watercourses (eg dams, water extraction) and
- earthworks (eg excavation, quarries, mining, fossicking)

## Introduced animals and environmental weeds: eg dogs, cats, cattle, Singapore daisy, Siam weed

- domestic animals are allowed on private land within the Area as long as they are prevented from entering rainforest
- grazing is allowed outside rainforests, but activities associated with grazing (maintenance of fences, dams, access roads, water access points) may require a permit

### Waste Disposal

Special provisions are made for private land holders with respect to waste disposal. However in most other circumstances, waste disposal is prohibited.

#### Building and maintenance of structures and roads

- freehold land owners are guaranteed a permit for building an approved residence, access road and establishing a housegarden, as well as drawing water for domestic use (conditions may apply)
- the Authority is only interested in maintenance works where the activity is having more than a minor and inconsequential impact on World Heritage values.

## Operation of motorised vehicles, boats and aircraft

- most roads currently open to the public will remain so
- unless otherwise indicated, all gravel and sealed roads are open to the public
- a few forestry roads will require a Wet Tropics permit for vehicle access but access can be applied for the same way as for Forestry permits to traverse
- there are some restrictions on motor boat use on waters above tidal influence, but no Wet Tropics restrictions on dams or Lake Barrine
- commercial aircraft: flying an aircraft in the WHA less than 1000 ft above ground level will require a permit eg scenic flights.

## You do not need a permit for the following

- protection of life or urgent protection of property
- transporting an animal (eg dog) through the Area
- activities with minor and inconsequential impact on World Heritage values and integrity eg low
  impact maintenance along private access roads or around residences (if in doubt, enquire at the
  offices listed at the end of this guide)<sup>1</sup>

## You do not need a permit if you are a private land holder (including leaseholds) who is:

- maintaining existing lawful firebreaks
- burning vegetation (other than in a rainforest)
- keeping undesirable animals on private land (other than rainforest)
- grazing animals (other than in rainforest)
- additional special provisions and allowances can apply for freehold land holders. Refer 'Land Holders with Ordinary Title'- Information Sheet No. 5 for further information.

If your activities are limited to these common sense exceptions or special circumstances you do <u>not</u> need to apply for a Wet Tropics Permit and do not need to read any further.

What if it looks like I might need to apply for a permit? What do I do next?

#### New proposals which include activities already regulated by QPWS or DNR

If your proposal requires completion of a QPWS or DNR application, and the proposal includes an activity described on page 4, you should ask for an application form that includes the <u>Wet Tropics Permit supplement</u>. The supplement is to ensure you do not have to go through two separate application and assessment processes.

Development proposals regulated by local government under the Integrated Planning Act.

- Development approval processes will be assimilated under the new *Integrated Planning Act 1997*, but this arrangement does not apply yet
- Until this time you will need to fill out a WT Permit Application Form as well as the required local government forms.

#### Permits to traverse

• Permits to traverse roads which have restricted access under the Plan are being administered under existing permit arrangements operated by DNRM.

## Proposals which only include activities regulated by the Plan

• Where the proposed activity is not also regulated by DNR or QPWS, a Wet Tropics Permit Application form should be completed.
